WHAT YOU NEED TO KNOW

- ☐ Display order for all sponsors and exhibitors - allocations are assigned automatically based on order of booking **and** payment of invoice. Allocations determine the sort order for each search conducted during the expo.
- ☐ **Virtual Booth** must be completed by no later than **October 23rd 2020**.
- ☐ **All cancellations** must be submitted formally via email. In the event that the organisers receive a request for cancellation prior to 2 months before the Expo date, a credit note will be issued for the full value of the booking. The credit note can be applied to any future booking for an Expo run by Social Impact Institute within the next 18 months. In the event of a cancellation within two months of the nominated Expo, no credit applies and 100% of the booking fee will be forfeited. It is the responsibility of the Exhibitor to review this information and if unclear, contact the organiser to seek clarification.

In the event that the organiser reschedules an event due to circumstances beyond its control then the exhibitor is entitled to a credit note, which can be applied towards a future or alternative event hosted by Social Impact Institute.
